The Corbitt House or The Haunted House Church Records Prop

The two handwritten pages should be printed onto opposite sides of a single sheet of white, or slightly off-white, paper.

They have been provided with simple corner cutting lines for those who wish to present the page as if cut from the Records Book.

For those who may wish to show the page as torn out instead, the page should be first cut straight at top and bottom using the cutting lines, and also at the right-hand edge when viewing page 2 of the PDF (the one beginning "Jan. 29th"). The left-hand edge is the one which should look as if it has been torn away.

The printed page lines have all been extended beyond the cutting lines to allow for printing errors, as well as to accommodate variations in the torn page edge, when required.

The last two pages of the PDF include a typewritten transcript for those who may wish to provide a version of the prop less subject to potential variations in interpretation of the handwriting.

As to what the various unusually-named activities and offices of the cult as detailed here may relate to, that can be safely left to determine by those running the role-playing games for which the prop was intended.
